A Muncy Creek Township Supervisors Regular Meeting was held at the Muncy Creek Township Building, 575 RT 442 HWY, Muncy, PA on Monday, October 20, 2025, at 7:04PM the meeting was called to order by chairman, Eric Newcomer followed by the pledge of allegiance. The following were present:

A motion was made by H. Fry II, seconded by G. Phillips to waive the reading and approve the minutes from the regular Supervisors meeting held September 15, 2025. Motion carried.

A motion was made by H. Fry II, seconded by G. Phillips to **receive the Planning Commission minutes** from the September 3, 2025 planning commission meeting as presented. Supervisor Phillips questioned if the fire company got with the Planning Commission regarding the Emergency Response Plan. A representative from Bollinger Solar was present and discussed what the fire company wanted added. Solicitor Wiley asked for something in writing from both Bollinger and the Chief for confirmation. Motion carried.

A motion was made by G. Phillips, seconded by H. Fry II to receive the WBRA Meeting minutes from September 10, 2025. Motion carried.

Public Works Director Report – September report received. A motion was made by H. Fry II, seconded by G. Phillips to **accept the public works director report** for September 2025. Motion carried.

Codes Report – A motion was made by G. Phillips, seconded by H. Fry II to **accept the Code Inspections Report** for September 2025. Motion carried.

Fire Company Report – The monthly reports for August and September were not available at this time. Scott Delaney was present and stated county is having issues with the CAD program. Scott Delaney present and stated there has been a lot of fires within the township in the last month and the one at Muncy Homes ruined almost \$15,000 in turnout gear. Delaney reported the Ambulance program has been up and running for a couple months and is working nicely.

A motion was made by H. Fry II, seconded by G. Phillips to **accept the check detail report as presented.** Supervisor Phillips questioned the two amazon purchases one for the spreader and one for the laptop. A motion was made by E. Newcomer, seconded by H. Fry II to **authorize bills to be paid** for this period. Motion carried.

Codification. Tabled until next meeting. Supervisors Newcomer to take a look and follow up with this.

A letter was drafted for the stormwater exemption by Solicitor Wiley. A motion was made by E. Newcomer, seconded by G. Phillips to **send the letter to Pleasant View Wesleyan Church** to grant their stormwater exemption request. Motion carried.

A motion was made by E. Newcomer, seconded by H. Fry II to accept decommissioning agreement from Bollinger Solar pending confirmation to remove salvage value. Representative from Bollinger Solar present and discussed what needed done. Solicitor Wiley suggested this get sent directly to the township Secretary. Motion carried.

Update on Tyler Road. D. Vassallo is working on this, table until next meeting.

Complaint/ Praise Form. Solicitor Wiley stated he will give guidance in executive session.

A motion was made by E. Newcomer, seconded by G. Phillips to accept resolution 2025-227 MCTSA Certification of Disbursement without disbursing the authority. Discussion was had about the benefits of keeping the authority vs disbursement. Motion failed.

A motion was made by H. Fry II, seconded by G. Phillips to **approve MMO Worksheet for 2026.** Supervisor Newcomer clarified what MMO stood for as well as this was in regards to pension. Motion carried.

A motion was made by E. Newcomer, seconded by G. Phillips to **approve advertising for Trick-or-Treating in Muncy Creek Township** on Friday October 31, 2025 from 6pm to 8pm. Motion carried.

A motion was made by G. Phillips, seconded by H. Fry II to appoint Elissa Stine as Tax Collection Committee Representative for Muncy Creek Township. Motion carried.

A motion was made by H. Fry II, seconded by G. Phillips to **approve boot camp training for Elissa Stine** on December 4th 2025, February 28th 2026, and March 7th 2026 for \$239. Motion carried.

Blinds for Meeting Room. Discussion occurred regarding what would best suit the door and windows. This matter was tabled due to lack of information with cost of tint on the door.

A motion was made by E. Newcomer, seconded by H. Fry II to approve request for Dynamic Energy's "Little Free Pantry" in the township with Elissa reaching out to local organizations and checking for permitting requirements. Motion carried.

A motion was made by E. Newcomer, seconded by G. Phillips to **fill temporary position- part time general worker- H. Fry II** replacing Dan Whitmoyer until the end of the year. Motion carried.

A motion was made by E. Newcomer, seconded by G. Phillips to **approve Monster Dash within the township** on October 25, 2025. Motion carried.
