A Muncy Creek Township Supervisors Regular Meeting was held at the Muncy Creek Township Building, 575 RT 442 HWY, Muncy, PA on Monday, May 18, 2026, at 7:00 PM the meeting was called to order by Chairman, Eric Newcomer followed by the pledge of allegiance. The following were present:

A motion was made by E. Newcomer, seconded by H. Fry II to **waive and approve the supervisors meeting minutes** from April 20, 2026 and April 29, 2026. Motion carried.
